## **INTRODUCTION**

The City of Goodyear initiated their General Plan Update process in February of 2022 and began a multifaceted outreach program to engage community members. The outreach program for this project is structured around a City Council approved Community Outreach and Communication Plan (COCP). This COCP was designed to be inclusive and educational by facilitating a meaningful conversation with Goodyear residents about the issues and opportunities that are most important in their community.

This report summarizes the public participation and input received during the first phase of outreach activities conducted from August through December of 2022. During this phase of outreach, multiple rounds of public outreach were conducted. Within each round, Community Workshops were held in three physical locations across the city as well as a separate Virtual Workshop Component. The in-person Community Workshops were conducted in an open house format, with multiple informational boards as well as feedback boards to receive direct input from participants. Upon entering the Community Workshop, participants were asked to sign in and given a comment card for any additional thoughts, questions, or comments. After walking through the different stations giving feedback, the participants were free to come and go as they please. Due to the recent comprehensive surveying done for the 2021 National Community Survey, no formal survey was sent out in concurrence with the workshops.

Target Workshops included smaller pop-up events and presentations to the public.

A Target Community Workshop was also conducted in southern Goodyear, within the Mobile community. This workshop included both components from Round 1 and Round 2 outreach efforts and are recorded in their respective sections. Responses from Mobile residents are indicated with a "\*".

The intent of this Summary Report is to present the information we received without making assumptions or recommendations. The feedback we received has been recorded within this document in order to memorialize key themes and ideas shared by Goodyear residents, and it will be used to help inform future work tasks associated with the General Plan Update, including preparation of a Vision Statement, evaluation of opportunities and challenges, land use changes, and the creation of new goals, policies, and actions.

As the project moves into the drafting phase, the General Plan update effort will continue to involve numerous opportunities for the public to learn about the project and provide their input, including traditional in-person and virtual workshops. #### **ROUND 1**

The First round of community workshops centered around explaining the purpose of the General Plan, existing conditions of Goodyear today and an evaluation of the existing community vision and fundamental strategies.

The in-person round 1 community workshops took place on the following dates and locations:

- April 28, 2022 Goodyear Recreation Campus
- June 1, 2022 Mabel Padgett Elementary School
- June 2, 2022 Estrella Foothills High School
- November 10, 2022 Mobile Elementary School

The Virtual Community Workshop for round one was open from July 6,2022 through November 30, 2022. The Virtual Community Workshop featured a virtual room where participants could navigate around the different stations to give input. Comments and tally of results are indicated under "Virtual Responses" for each of the respective sections.





Approximately 31 people total signed in among all three in person workshops and 35 people to the virtual workshop for round one.

The workshop was broken down into three stations:

- Station 1: What is a General Plan? And Existing Conditions
- Station 2: Vision Review & Community Mapping Activity
- Station 3: Review of the Fundamental Strategies

#### STATION 1: WHAT IS A GENERAL PLAN? AND EXISTING CONDITIONS

# What is the purpose of the General Plan?

The Goodyear General Plan is the community's long-range guide for future physical, economic and social development decisions over the next 20+ years. The General Plan contains a vision statement, along with maps, goals, policies, and implementation strategies that address issues such as land use, growth, circulation, parks and open space, and the environment.

# Why update the General Plan now?

State law mandates that each city and town in Arizona adopt a "comprehensive, long-range general plan for the development of the municipality." These plans must also be updated and adopted by voters every ten years. The City of Goodyear's current General Plan was last ratified by voters in 2014.

# What topics does the General Plan address?

There are both State-mandated and optional "elements," or topics, that go into a General Plan. State law requires that a General Plan for a community the size of Goodyear address the following elements:

- Land Use Revitalization & Redevelopment Conservation
- Circulation & Bicycling Neighborhood Preservation Energy Safety
  Growth Areas Environmental Planning Public Services & Facilities Cost of Development
- Open Space & Recreation Water Conservation Public Buildings

To maintain Goodyear's innovative and forward-thinking culture, the General Plan may also include additional elements that cover topics such as:

- Economic Development/Workforce
- Arts & Culture
- · Healthy Communities
- Social Services
- · Technology
- Tourism








## **POPULATION PROJECTIONS**

#### STATION 2: VISION REVIEW & COMMUNITY MAPPING ACTIVITY

#### **VISION**

Station 2 included a feedback board that allowed participants to share comments on the existing vision statement and whether supportive values should be kept, removed, or revised.

The following comments were received in-person when asked what was liked or what needed to be changed within the existing General Plan vision statement:

- "Art district"
- "Heritage Park Goodyear history"
- "Gila River restoration as a priority"
- "Goodyear needs a unique identity that is known by outside the city"
- "Destination place-state & national notoriety[recognition]"
- "Art Supplies store!"
- "No Change"

The following comments were received in the Virtual Workshop when asked about the vision statement:

- "Preserve the neighborhood community appeal, maintain a growth strategy complementary to existing design while protecting property values and create a place we are proud to call Goodyear."
- "It is too broad of a statement. Obviously, every city wants that exact thing. Is this statement meant for the residents or businesses and money they are trying to bring in?"
- "I would love to add more unique areas that make Goodyear stand out, like a monument that places Goodyear on the map"
- "As written, this statement is too generic and lacks inspiration. It needs to evoke an emotion and connection that is unique to Goodyear and those key elements that set us apart."
- "Change nothing but would like to see that we live by this vision for all residents"
- 'Looks good!"
- "Create a destination city that is highly desirable and is a sustainable place for all to live, work, visit, and play"
- "You cannot create a sustainable resource, so I believe Support should replace Create, but my concerns are how do you plan and support sustainable resources when your focus is economic growth? Creating higher density housing utilizes far more resources than the same footprint for detached homes.
  Population growth and economic growth should not outweigh sustaining our water resources. The Vision Statement does not match the actions the City is doing with its development."
- "I agree that we should create a desirable and sustainable place to live, but it seems Goodyear is not going in that direction. There seems to be an initiative to build something on every piece of land in Goodyear and that is not sustainable. Take a look at the former downtown off Litchfield and Yuma/Western. multiple abandoned strip malls that sit with no further development, the city looking into redeveloping that area prior to building new? New draws from the old and I fear we will see more areas in Goodyear become abandoned."
- "I like it, but I would love to add something about making Goodyear an inclusive or equitable place to live."

The following General Plan values were evaluated by the public on what to keep, remove, or revise:

# Foster a sustainable community with diverse destinations connected throughout the city (3 Keep votes, 6 Revise Votes)

- In-person comments:
  - "Destination is that a place to visit or a place to live? How does this fit the work industry?"
  - "What do you mean by sustainable? Physical environment like trees water dust control?"
  - "What do you mean by diverse destinations does this address lack a public transportation?"
  - "Beyond bicycling what is being considered for bus type vehicles with an AI to drive to and from?
     The price of gas well soon limit in the ways we are easily able to travel."
  - "Too many chain restaurants we need more local Businesses to keep money in the community"
  - o "Currently the city is not very bike-walkfriendly bike lanes end without notice"
  - "Cannot bike to Bell Park and restaurants because there is no bike lanes or sidewalks on large portions of road"
  - "Currently not very walk bike friendly"
  - "Bike lanes end randomly"
  - o "High speed rail connecting west and east valley. (Buckeye to Scottsdale?)"
  - "Enhance mass transit including circular buss + park + rides."
  - o "Rapid/express bus from west to downtown."
- Virtual Comments:
  - o "This is difficult to measure, what are the checks and balances?"
  - "Sustainable is not the correct word for this statement. Enjoyable maybe, but there is nothing sustainable about a community. High populations consume more resources, create more trash, and over consume"

# Encourage growth by offering opportunities for cultural educational and economic development (2 Keep Votes, 2 Revise Votes)

- In-person comments:
  - o "Revise to encourage responsible growth not just growth of the sake of growth"
  - o "I would like to see college curriculum classes targeted to seniors"
  - "Affordable housing period!!! Goodyear is losing young families!"
  - "Attract stores like TraderJoe's, tourism!"
  - "Continue to expand events. Doing good job so far."
  - "More arts and cultural activities i.e. More shows, plays, concerts in small and larger scales
- Virtual Comments:
  - o "Again, difficult to measure so how do you know you are/have done this?"
  - o "Too broad of a statement."
  - "But enough of all the big warehouses in our neighborhood"
  - "Encourage sustainable growth by developing infrastructure, innovative solutions for resources that offer opportunities for cultural, educational, and economic development."
  - "Please include recreational and remove economic development. Economic development to me means money and we shouldn't be lump that in with cultural and educational opportunities. Economic development should have a separate value. People flock to areas that are strong in cultural and educational development. No one (other than the wealthy) seek economic development."

#### Recognize our asset's history and open space (3 Keep Votes, 1 Revise Vote)

- In-person comments:
  - o "Acknowledge the land and which we stand. What indigenous people?"
  - "Keep and grow hiking trails"
  - o "PICKELBALL!"
  - "More Pickleball courts!!"
- Virtual Comments:
  - o "Add something to make the city stand out on the map, better bus systems."
  - o "Recognize our assets, history, and open spaces and diverse communities"
  - "Recognize and support our assets, history, and open spaces"
  - "I like it but perhaps add something about recognizing the ancestral tribal land that Goodyear sits
    on, recognizing the history and open spaces."

# Maximize Partnerships and collaboration (2 keep votes) (No comments)

- In-person comments:
  - o "Utilize collaboration with local cities, like chandler, on how they handled their fast growth. Ask what worked what didn't. "
- Virtual Comments:
  - "What does this mean and on what level? Partnership between the government and new businesses? How do community members fit in? I feel a vision statement needs to be measurable or it's just a bunch of pretty words that sound nice but have no real value."
  - "Is that a benefit to the residents or just money being brought in?"
  - "Seek out and maximize partnerships and collaboration"
  - "This is too vague. What partnerships and collaborations are you speaking about?"

Collectively, the public re-affirmed the community values from the existing General Plan. The data from the inperson and virtual workshop have been aggregated below:

#### **COMMUNITY MAP**

The Community Mapping Activity of the workshop was presented on a board where residents could place different dots to represent areas to Preserve, Improve, or Target Growth. The Virtual Workshop included an interactive virtual map where participants could also leave map pins with the same categories. The online mapping activity received 30 comment Pins total.

In Person, 58 dots were placed on the Map Board. "Areas to Preserve" were identified in clusters around Estrella, along the Gila River, and mountain ridges in the southern planning area. "Areas to Improve" were clustered around the old city center, around the Goodyear Airport and Ball Park, Waterman Wash in South Goodyear, Gila River Crossings at Cotton Lane and Estrella Parkway, and the far northwest corner of the city. "Areas to Target Growth" were identified in Goodyear North of I-10, Estrella, and parts of Mobile (See *Figure 6*). The Virtual Community Mapping Activity had a total of 30 comment pins identified (See *Figure 5*). Comments from both can be found below:

## • In-person comments:

- "Upscale hotels, facilities for events and things open for night life (North Goodyear)"
- o "DOES NEED TO BE CLEANED UP AND ENFORCED (North Goodyear)"
- "Additions to Foothills Community Park: 4-6 Sand Volleyball Courts, 2-70/90-foot baseball fields
   2-Adult softball fields"
- "More Infrastructure for South Goodyear"
- "Estrella Parkway traffic need help"
- "Preserve City owned property surrounding ballpark. No more housing!"
- o "A performing arts (indoor) venue would attract tourism and beautiful local high school performance groups: band, theater, choir. Name it after Mayor Georgia"
- "Need Fire Protection in Mobile"\*
- "Water Pump in Mobile"\*
- "Plans to make South Goodyear a scenic neighborhood like Anthem will be hindered by the I-11. Please fight to move the corridor away from the neighborhood or take it UNDER the railway otherwise we will end up like the one like the 202"\*

#### • Virtual Comments:

- Areas to Preserve:
  - "I'm among the individuals that DO NOT want development in the area surrounding the ballpark. I live in this area and it's becoming increasingly congested. The city should purchase this land and use it for further recreational use. Goodyear could benefit from creating a facility similar to the Scottsdale Sports Complex. This would preserve the land and allow residents to still enjoy the beautiful Mountain View's that attracted us to the area in the first place."
  - "The vacant lot next to Canyon trail center. Front part is to be houses and condo, but please keep back part open. To many buildings going up losing openness, that's why we moved here to openness. Across street is the center. Like to walk the trails and view the scenery not buildings!"
  - "The Gila River can be a gem for the city. We have a choice surround it by industrial, as currently zoned, and allow it to turn into an area of blight and trash like the Salt River through Phoenix; or surround it by residential and commercial, turning it into a natural amenity with trails, trees, and water, similar to what you see around Tempe Town Lake which is a major economic driver for that area."
  - "The Goodyear Airport is home to significant history for our country and also is a one-of-a-kind place to view different types of airplanes from all around the world (the many uniquely decorated tailfins. It is beautiful and something you won't find anywhere is in

- the world). Consider creating an observation park where families and aviation fans can watch the planes and learn about the history. Examples can be found at Falcon Field (MSC) and Dallas Fort-Worth (DFW)."
- "Complete Bullard Wash Trail south of I10. Include many shade trees to make it an enjoyable feature even in the warmer months. Consider including grass, at least in pockets, similar to what has been done north of I10. Make the path visually pleasing with curves, hills, & amp; art. Ensure there is a pedestrian-oriented connection, also with lots of shade trees, to the Goodyear Recreation Campus Possibly the Maricopa Trail along Yuma Rd. or a separate path through the existing Centerra neighborhood."
- "Partner with arts and culture groups to preserve and repurpose historic downtown as a gathering place and point of pride."
- "I love this park, I'd love to see it protected and expanded, some larger shady trees would also be nice. I don't love all the buildings popping up around it taking away the view of the mountains. I understand that we can't stop them but limiting it to only what's needed as I'd hate for the guiet of the area to be taken away."
- "Original Business District. It's historic and the current owner has done so much to preserve the buildings and use them for current needs."
- "Palmateer Park, was the first and only parkin Goodyear. Also the site of original water well. It has been enhanced with an art project and needs to be preserved."

#### Areas to Improve:

- "This is the perfect spot for a gas station as QT by the 10 is always so busy and going to the south side of the 10 is a pain." (Southeast corner of Virginia Ave. and Pebble Creek Parkway)
- "This would be a great spot for a grocery store. I would love to see it re-zoned commercial." (Northwest corner of Monte Vista Rd. and Pebble Creek Parkway)
- "Yuma Rd is a designated as a "Scenic Arterial" and carries a large amount of traffic. It is also a part of Maricopa Trail - an important east-west pedestrian corridor. Despite this, it is incomplete in many areas and is quite ugly compared to other roadways within Goodyear. It is the only road with span-wire traffic signals, lacks bike lanes & the sidewalks in multiple areas, and most importantly lacks the shade trees & the span wire trail."
- "Central Goodyear has a higher population & apt; significantly more approved and under construction housing (multi and single family) than north Goodyear. Despite this, there are only 14 full-service sit-down restaurants in central compared to 36 in north Goodyear. The city continues to focus on attracting entertainment, higher-end restaurants, and building amenities north of I-10, despite that not being where the majority of the population resides today or where most growth will occur in the future."
- "Build-out the Maricopa Trail along Yuma Rd. The city needs an east-west pedestrian corridor south of I10. Include shade trees, artwork, bike racks, benches, water fountains, and signage. See the trail that the city of Avondale has built along the north side of Van Buren through their city as a great example of what this could be. Having high-quality trails and walkability is becoming increasingly important to attract people and high-end employers and promotes a healthy lifestyle."
- "Utilize existing Roosevelt Irrigation District right-of-ways to create pedestrian/bicycle corridors. The canal has been buried at this location, but it is an unobstructed path from Van Buren to Elwood that is already used informally by residents for walking/jogging. It can connect neighborhoods Wildflower Ranch, Glenmont Estates, Estrella Vista, Sarival Village, & Desert Store to destinations such as the Safeway shopping plaza, Goodyear Rec Campus, Basis, Desert Edge HS, Desert Star, and Legacy."
- "Dangerous intersection at Sarival and Lower Buckeye needs traffic calming or signals.
   Limited visibility for vehicles on Lower Buckeye."
- "Dangerous intersection at Sarival and Lower Buckeye needs traffic calming or signals.
   Limited visibility for vehicles on Lower Buckeye."

- "This intersection can be dangerous at times, especially with the right turn on red rule that makes it hard to cross even when the walk sign is up. Love to see a no right turn on red sign implemented."
- "Needs a pedestrian guardrail. Crossing under the highway can be dangerous as the sidewalk is so narrow and brittle, biking or walking is impossible at times." (I-10 and Estrella/Pebble Creek Parkway)
- "There is no over bridge crossing here which is dangerous as people end up crossing and there's nothing for cars to tell them to stop. A pedestrian crossing here would be really nice" (Bullard Wash and Monte Vista Rd.)
- "Connect the 303 to I-11 to provide faster commuting for those in south Goodyear. Reduces back road traffic as well, allowing for more walkable/bike-able areas."

#### Areas to Target Growth:


- "The Ballpark and the area around it is beautiful. Given the amount of residents in this area today and the tremendous amount of residential growth occurring here now and in the future, this is an ideal spot for walkable entertainment, restaurants, and a regional attraction like a museum or aquarium. The location is uniquely prime since it will be surrounded by highways on three sides, I10, 303, and SR30, making it a convenient destination not only for Goodyear residents but the entire region."
- "Lower Estrella Mountain Ranch could use a ton of growth. Gas station, grocery store (Sprouts would be amazing!), restaurants/coffee/bar/etc."
- "I would LOVE to see increased walk/bike-ability between residential, commercial, park, and trail areas. For example, I live in a 2-mile radius of many attractions, including civic square, that I should be able to access by walking/biking, but crossing any of the main roads is DANGEROUS; getting in my car further congests traffic and takes longer than a bike ride. Systematic over/underpasses plus dedicated walking/biking trails that connect residents to their community would be amazing!" (Palm Valley)


## o Other Comments or Questions:

- "What is that? Is that the park, in canyon trails 3? Green space, is something being put up there? Please call 4146595815. I own a house in area. Thx"
- "Work with ADOT to ensure a safe, pedestrian-only crossing for the Maricopa Trail when the 303 is expanded south past Yuma Rd. The 303 will create division between this area of Goodyear if there is no dedicated pedestrian crossing. As an example of what not to do, try walking/biking under I10 along Estrella Pkwy while dodging all the traffic going on/off the ramps it is not for the faint of heart. Consider a dedicated bridge or tunnel to make this important regional trail safe and enjoyable."
- "Enhance Bullard Wash to continue trails and paths that do not require crossing traffic (use tunnels, overpasses) to the dog/bike park and across to Estrella Park and preserve. Interconnecting natural spaces throughout the city from top to bottom will make a world class destination for recreation for non-motorized activities. Access points with parking at key locations. Relyon mostly non-paved paths for runners, horses, and bikes and to preserve the natural landscape."
- "Opportunities to partner through Lower Gila River Collaborative and Rio Reimagined to enhance the river and provide recreation and access. Estrella Mountain Regional Park (MCPRD) and Flood Control District in particular have several active projects in this area to remove tamarisk, re-establish native vegetation, and provide safe, legal access to the river."
- "Please consider developing eco-friendly public transit systems in/out of Estrella, between residential and restaurant hubs/areas, and the new civic and recreation centers! I would love to be able to go to a ballet/concert at Estrella amphitheater or check out a revived historic downtown; but driving in this city is congested and biking on the roads is dangerous. I don't see this lessening given the city's rapid growth without a system of walking/biking trails and public transportation."

"With development going on at every intersection nearby it would great if we could keep this area to enjoy as residents as a park or something that isn't more retail. With the high school, recreation campus and ball field! feel like there is an opportunity to develop a "small town" feel and bring residents together instead of an other busy restaurant or shopping center."

Figure 5: Online Mapping Activity






#### STATION 3: STRATEGIES REVIEW

The last station asked participants to evaluate the relevancy of the nine "Fundamental Strategies" in the existing General Plan. Understanding a lot has changed over the past decade, participants were asked whether or not the Fundamental Strategies are still important today. The results from both the virtual and in-person have been aggregated below in *Figure 7*. Overwhelmingly the public affirmed the importance of the Fundamental Strategies in the existing General Plan, with some minor revisions needed for specificity and better relating the strategies to community values.

Specific comments in relation to the individual Fundamental Strategies are captured below:

#### Strategy 1: Create Attractive Places and Diverse Destinations

- In-Person Comments:
  - o "Encourage local entrepreneurs to open unique businesses restaurants i.e., food truck parks and food truck operators become restaurants"
  - "Does this include work live playareas?"
  - "Gas station in Business restaurant early in southern planning"
  - "Continue to expand retail/restaurant west and south"
  - "Walkable entertainment district"
- Virtual Comments:
  - "More natural open spaces. Less parking lots and strip malls"

## Strategy 2: Develop a Physically and Socially Connected Community

In-Person Comments:

- "Goodyear ambassador program"
- "Fiber optic will help us thrive"
- o "Public transportation using green energy shuttles, buses park and ride lots"
- o "More phone Lines?"

The amount of money used to maintain and reseed that area should use in the rec area as that's where all the families spend most of their time. "

- "I love living in Goodyear and totally understand the growing pains first and foremost Goodyear needs to be affordable available housing a lot of young families are leaving Goodyear because of the high cost of living they want the small town feel with all the modern comforts and amenities without paying Scottsdale prices for simple housing I don't like outside companies been able to come able to buy up and stack up apartment complexes or subdivisions that are overpriced. Goodyear needs its own school district due to the overcrowding of the nine school districts that Goodyear borders and families have to send children to."
- "Slow controlled growth. Too many apartment builders are coming in and rezoning the commercial property to multi-family. The city needs to attract builders and allow single-family detached homes. This will please people who didn't want apartments and provide affordable, home ownership to young adults. Townhomes/row houses seem to be the compromise. We also need to maintain open spaces. It is proven that overdevelopment increases surface temperatures. We do not want to become Mesa. We need an entertainment district at the ballpark to attract young people. Central Goodyear/former city center has been abandoned by the city. We want things to do. While we love GRC, we need nightlife surrounding the ballpark.

We need wider sidewalks with actual shaded trees. Pressure developers to utilize trees that are strong and provide shade. Not trees that will fall over in storms and break. Ensure that open spaces are accessible to all citizens not just ones and cheated gated communities. Please preserve city owned lance rounding ballpark. Highly disappointed in the constant reasoning to residential. We need a walkable district the city currently only cares to those who live in Pebble Creek."

- o "More residential areas. Parks and dog parks. Also, focus more on public transportation in the area."
- o "I would recommend more recreational and retail spaces for young adults. Improve public transportation."
- "Recommend that police and fire are on high priority to stay ahead of the growth. Of course, water needs to be much concern. Electric power must stay ahead of growth to avoid blackouts.

#### **ROUND 2**

The second round of community workshops centered around planning priorities, character of the built environment, and evaluation of the existing land uses and plan. 

#### STATION 1: PLANNING PRIORITIES

The first station in the second round of community workshops focused on confirmation of "Planning Priorities". From the first round of public input, the following key themes were consistently repeated as a significant consideration for the future of the city: More Retail Options, Reduce Traffic Congestion, Enhance Water Conservation, Provide More Diverse Housing, Additional Open Space & Parks, and Manage Warehouse (Big Box) Development. Participants were instructed to select their top priorities and list any other priorities that were not identified. This board was also duplicated and presented at the City Hall Grand Opening Ceremony on August 1, 2022, and the Fall Festival on October 29, 2022. *Figure 11*: Planning Priorities Aggregated summarizes the cumulative data from Round 2, the City Hall Grand Opening, and Fall Festival for Planning Priorities.






#### STATION 2: COMMUNITY CHARACTER AND LAND USE

The second station in Community Workshop #2 provided the opportunity for the public to give feedback on overall development character, the existing individual General Plan land use categories, and the existing General Plan land use plan.

#### COMMUNITY CHARACTER PREFERENCES

This station allowed participants to give input on the overall development character for the City. Considering the rapid growth of Goodyear and large undeveloped areas in the southern planning area, participants were asked to rate on a scale their preferred development pattern, commercial character, employment character and housing character. The number of votes from both in-person (See *Figure 15*) and the virtual workshop survey were tabulated and averaged to get a composite score representative of the overall sentiment from the public (See *Figure 14*). Development Pattern leaned more toward "Nodes" with an average score of 3.5. Commercial Development character leaned more towards "Walkable" with the highest average score of 3.9. Employment Development Character leaned more towards "Vertical Mixed Use at 3.6. Housing Development Character had the lowest average at 2.3 falling in the middle range between "single unit housing" typologies and "context appropriate mixture of housing".





#### **ROUND 2 COMMENT CARDS**

The following comment cards were received during Round 2 of Community Workshops:

- Virtual Comments:
  - "The board members must understand their decisions impact everybody in Goodyear. Please maintain an open-mind and set aside your personal preference during this process. Thank you."
  - "Our plan does not address the electrification of our economy. I believe that is our future for the next 30 years."
  - "My primary concern about future development is to make sure the roads can handle the increased trafficthat will be generated. ADOT pushing out 303 construction to the 2030's is not helpful for those of us living below I-10. Please keep this in mind."
  - "Thank you for asking for input from us ordinary folks. I would be willing to participate in a live discussion if you have any of those in the future."
  - "Goodyear is currently a very automobile-centric suburb, but it has some great foundations that can be utilized to turn into a walkable city. Existing trails along the canals, Bullard Wash, and HOA neighborhoods just need to be more strongly connected together, new development needs to create more pedestrian/bike only corridors, more shade trees should be planted along walkways, and commercial (shops, dinning, and offices) needs to be more evenly distributed throughout the city to create walkable destinations. Younger generations are craving a walkable, sustainable city for the future. Goodyear can get there, but it needs to focus less on the old car-centric development and more on the person-centric development."

#### TARGET WORKSHOPS

To further extend outreach efforts for the General Plan Update, Target Workshops were held over the course of this first phase and included many pop-up booth events, informational presentations, and stakeholder discussions. The following summarizes these targeted events.

#### CITY EVENTS

One area of focus for Target Workshops was City Events in coordination with the programming schedule. These pop-up booths targeted quick feedback exercises for the public and increasing informational awareness about the General Plan Update.

#### CITY HALL RIBBON CUTTING CEREMONY 8/1/22

The City of Goodyear hosted a Ribbon Cutting Ceremony and Grand Opening of the new City Hall in the morning of August 1, 2022. Various departments and City initiatives also had booths present at the invent. Hundreds of residents were present and booth participants were invited to indicate planning priorities for Goodyear and to learn more about the General Plan. Comments on the Planning Priories Board in relation to additional City Priorities included:



#### PEBBLECREEK PRESENTATION 11/16/22

An informational presentation on the General Plan was coordinated with the Life-long Learners Community Group in Pebble Creek. 35 people signed in and approximately 40 people attended. The presentation was followed with a brief question and answer session. Comment Cards received from the meeting are displayed below.

The informational presentation educated participants with an understanding of the General Plan and then guided them through a series of 5 discussion questions to get feedback. The questions and their feedback has been recorded below:
